About \$751 million will be used to replace Indiana's water infrastructure system – delivering safe and clean water to all Hoosiers, more than \$680 million will be used to update public transportation systems in cities around the state, and an additional \$100 million to further expand broadband internet, about \$100 million to expand the state's electric vehicle (EV) charging network, and \$20 million to help the state fight the impact climate change has on our communities. If elected I would make sure that Vigo County gets its fair share of the Infrastructure Investment and Jobs Act.

Local communities struggle to maintain what they have – let alone thinking about how to improve or expand. I strongly back making significant and strategic investments in Vigo County's infrastructure through the targeted use of federal and state dollars.
